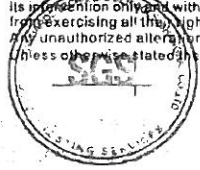

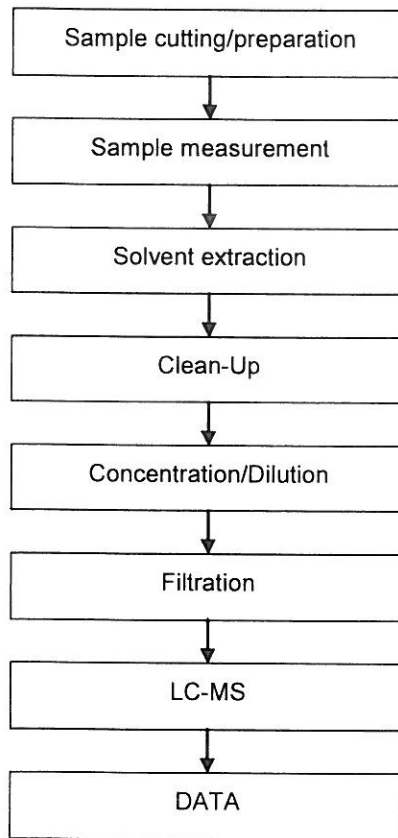

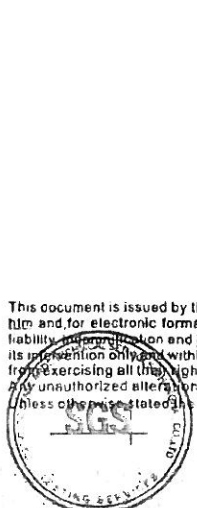

BPA Testing Flow Chart

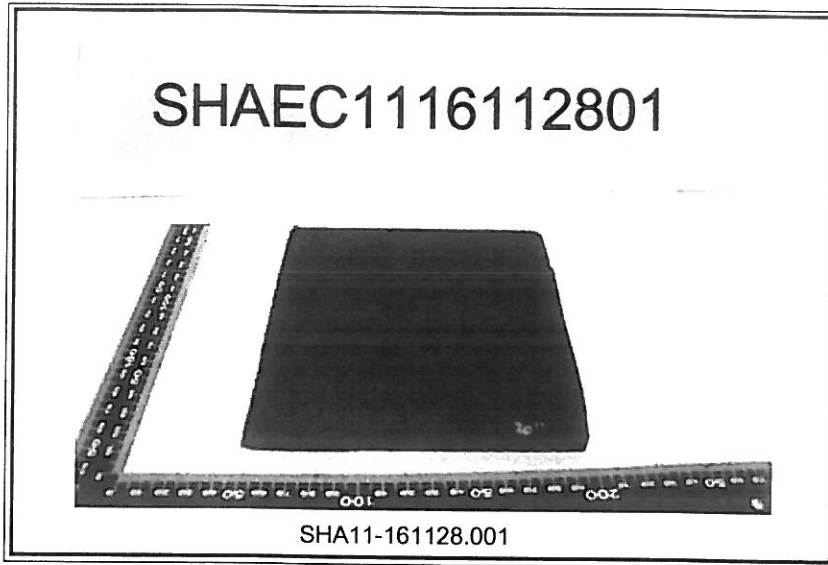
