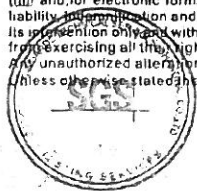

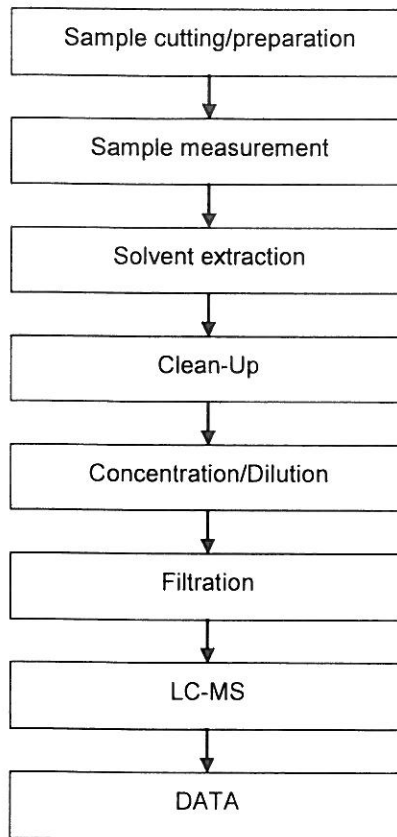

### BPA Testing Flow Chart

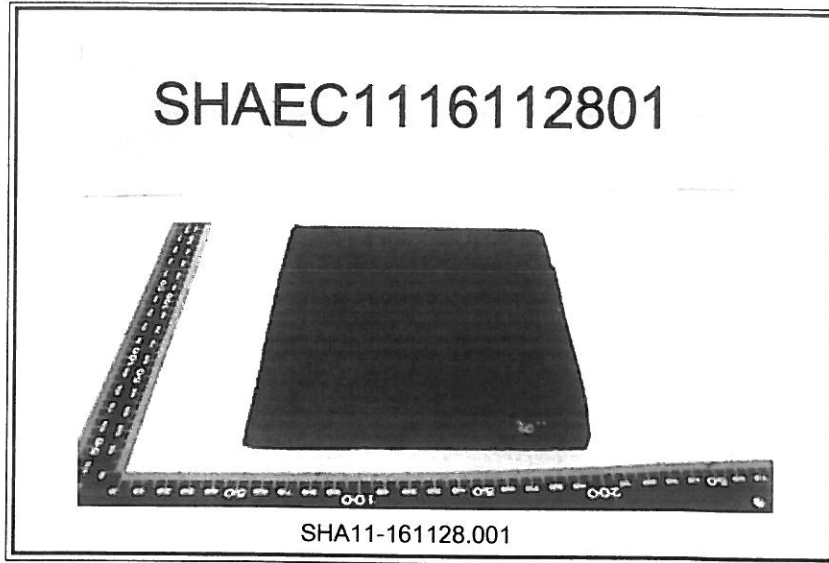
