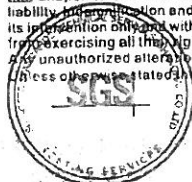

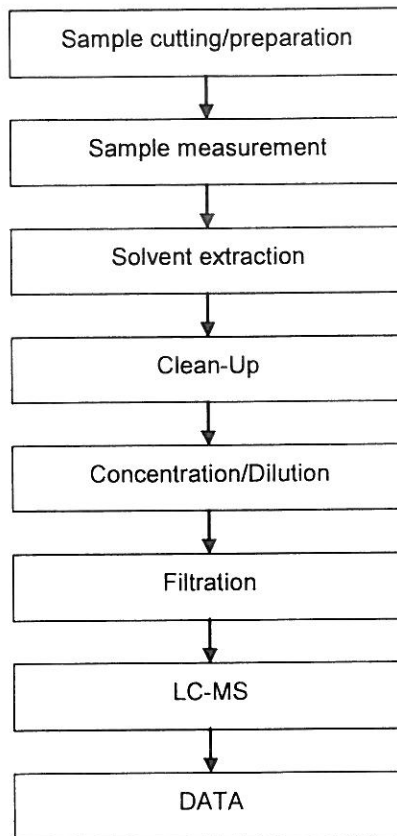

BPA Testing Flow Chart

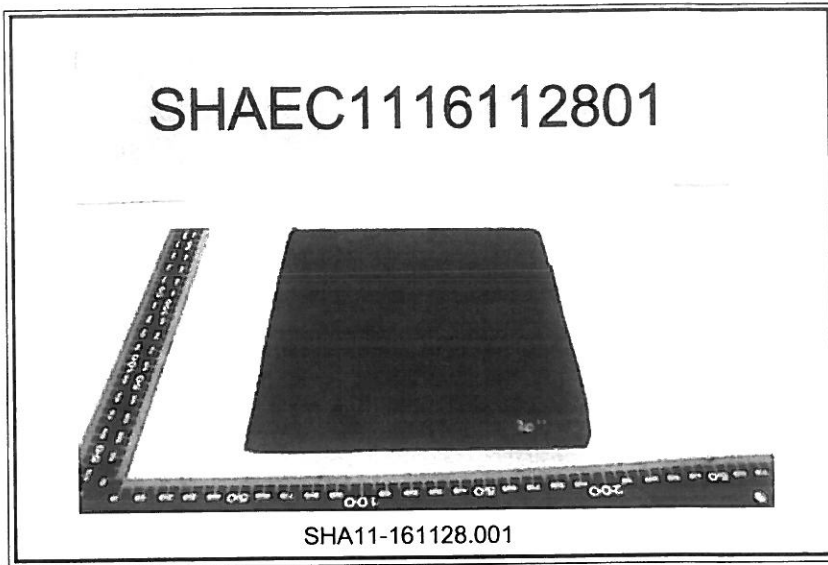
