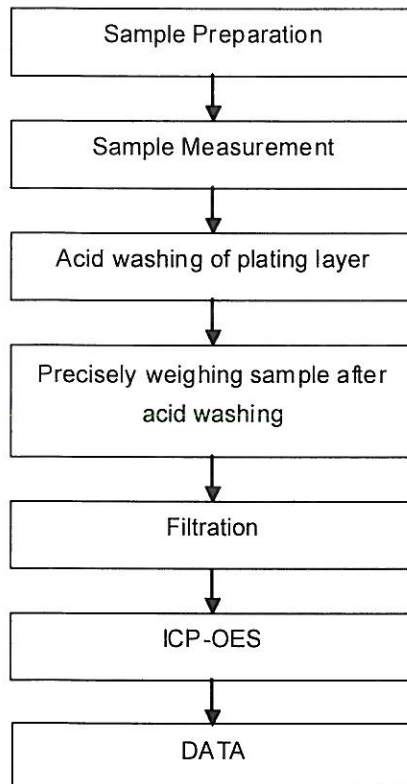

**Plating Pb Testing Flow Chart**

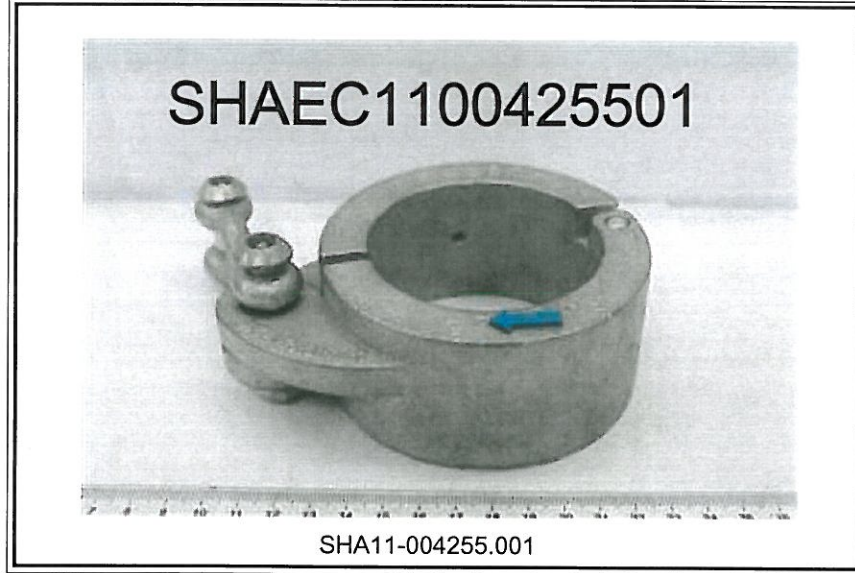
